Registration of fictitious names [2] Notice to abate. [2] Any person, firm, or corporation using a fictitious name in contracting or in the doing of business shall register the same in the office of the clerk of the circuit court of the county in which said contracting or doing of business is done or where the contract is to be performed, and shall notify the clerk of such registration at least thirty days before beginning to do business under a fictitious name.
