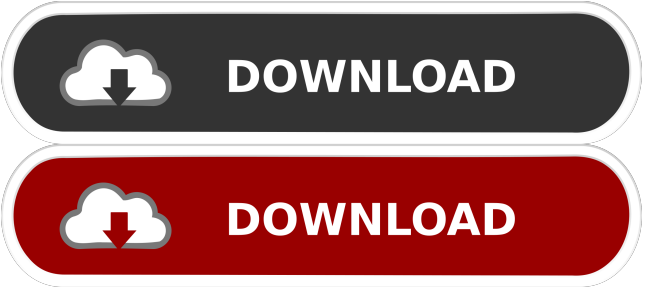

The English translation which is for the most part not complete starts on page 91. They are for the most part in sync but you are right on the proviso that there are differences of opinions. . The trial court's finding that Qazvini did not intend to defraud the debtor is not clearly erroneous. See In re Lesjak, 69 B.R. at 748. An additional reason the bankruptcy court properly denied the motion for reconsideration is that Qazvini failed to plead the defense of lack of consideration or its equivalent. As the court stated in its order denying reconsideration: [T]he debtor's pleadings are deemed amended to conform to the evidence presented at trial. * * * The debtor's exhibits were received and are deemed part of the record * * * [and] the alleged lack of consideration is a `fact' which is alleged in the defendant's answer. Bankruptcy Docket No. 56, p. 2. * * * * * The [b]ankruptcy [c]ourt previously found that there was consideration for the debt. In fact, the [b]ankruptcy [c]ourt stated it was "too simple a matter" to determine that the debtor signed the note and deeds of trust in consideration of the loan. *585 * * * * * [W]e find that the [c]hapter 7 debtor intended to repay the loan when she signed the note. * * * * * [T]he [c]hapter 7 [t]ransfer was made within one year before the date of the filing of the petition. * * * * * Id. at pp. 2-4. Qazvini now argues that the bankruptcy court erred in permitting the defense of lack of consideration or its equivalent to be amended to conform to the evidence. The court disagrees. 3ef4e8ef8d
